Cindy Carlson

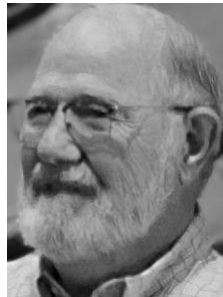

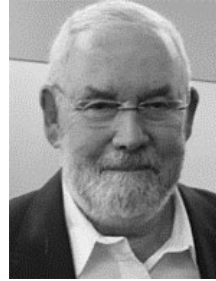
