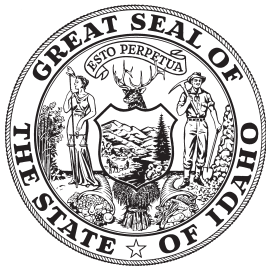

## Register to Vote

With this form, you can register to vote in elections in Idaho.

### You can also use this form to:

- Report a change of address
- Report a name change
- Affiliate with a political party, or
- Change your party status to unaffiliated

### Are you eligible to register?

To be eligible to vote in Idaho, you must:

- Be a citizen of the United States
- Have resided in Idaho and in the county for thirty (30) days prior to Election Day, and
- Be 18 or older on Election Day

### How to return this form

Return your completed and signed form to your county elections office. You can:

- Drop it off in person
- Mail it

If mailed, this form must be postmarked by the 25th day before an election. Your county elections office will notify you to let you know that your registration was received.

A current valid driver's license or identification card issued by the Idaho Department of Motor Vehicles is required.

### Your identity

You must provide your date of birth and **1 of the following:**

- Your Idaho Driver's License or I.D. number
- Or**
- The last 4 digits of your Social Security number

If you don't have a state issued I.D. or a Social Security number, please contact your county elections office.

### Your addresses

You must register at your residential address. This is the address where you currently live.

If you receive mail at a different address from your residential address, provide a mailing address.

If you are already registered somewhere else, please provide your previous registration address.

### Registering in Idaho for the 1st time?

If you are registering in Idaho for the 1st time, you must provide a copy of the following:

- An approved form of photo identification
- And**

- An approved proof of residence document

A list of approved photo identification and proof of residence documents are listed below.

## Identification Required to Register

All voter registrations must provide one of the approved photo identification and proof of residence documents in order to complete the registration process. You will be unable to receive a ballot until this requirement is satisfied.

### Approved Photo Identification:

- Current Idaho Driver's License or Identification card
- Current U.S. Passport or Federal photo Identification card
- Current Tribal Identification card
- Current Concealed Weapons License issued by a County Sheriff in Idaho

### Approved Proof of Residence:

- Any of the above photo IDs with correct residence address
- Current proof of insurance
- Deed of trust, mortgage, lease, or rental agreement
- A property tax assessment, bill, or receipt
- A utility bill, excluding a cellular telephone bill
- A bank or credit card statement
- A paystub, paycheck, or government-issued check
- An intake document from a residential care or assisted living facility
- Enrollment papers issued for the current school year by a high school, or an accredited institution of higher education located within the state of Idaho
- A communication on letterhead from a public or private social service agency registered with the secretary of state verifying the applicant is homeless and attesting to the applicant's residence for registration purposes
