<p><b>CANDIDATES FOR CITY OF LEWISTON OFFICES</b></p>	<p>SHALL THE CITY OF LEWISTON BE AUTHORIZED TO INCUR INDEBTEDNESS AND SELL ITS GENERAL OBLIGATION BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$22,540,000 FOR CONSTRUCTING AND IMPROVING WASTEWATER, WATER, STORMWATER AND ROAD INFRASTRUCTURE, THE BONDS TO MATURE AND BE PAYABLE FROM A LEVY OF TAXES FOR A TERM WHICH SHALL NOT EXCEED THIRTY (30) YEARS?</p> <p>If a full tax levy is needed to make the annual bond payment, the following disclosure will apply:</p> <p>The anticipated interest rate on the proposed bonds is 3.75% per annum. The estimated annual cost to the taxpayer on the proposed bond levy is a tax of \$30.47 per \$100,000 of taxable assessed value, per year, based on current conditions.</p> <p>The total principal amount to be repaid is \$22,540,000; the total interest to be paid is \$15,381,125; thus, the total amount proposed to be repaid over the life of the bonds is \$37,921,125.</p> <p>Bonds proceeds will be used to construct wastewater, water, stormwater, and road improvements.</p> <p>The City has outstanding indebtedness of \$24,755,360, payable only from sewer revenues and outstanding indebtedness of \$38,821,845, payable only from water revenues.</p> <p>The City intends to use annual appropriations from: general funds, water, and sewer revenues to make bond payments and minimize or eliminate the need for a tax levy.</p>

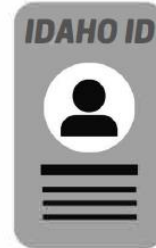
