TIMED CONTRIBUTION REPORT

PURSUANT TO IDAHO CODE 67-6607(3)

Notwithstanding any other reports required under this section, each candidate and each political committee, or the treasurer for each candidate or political committee, shall notify the Secretary of State of any contribution of one thousand dollars (\$1,000) or more. This notification shall be made within 48 hours after the receipt of such contribution and shall include the name of the candidate, political committee, or measure, the identification of the contributor, and the date of receipt and amount of the contribution. The notification shall be made in addition to the reporting of these contributions in the regular reports.

This requirement applies to all types of contributions, including but not limited to:

- Itemized Contributions
- In-Kind Contributions
- Loan Received
