Shall the Board of Trustees of Highland Joint School District No. 305 be authorized to levy a supplemental levy in the amount of \$599,000 per year for a period of one year commencing with the fiscal year beginning July 1, 2025, for the purpose of maintenance and operation of the school district as provided in the resolution of the Board of Trustees of Highland Joint School District No. 305 adopted on March 10, 2025?

The following information is required by Section 34-914, Idaho Code:

The estimated average annual cost to the taxpayer on the proposed levy based on the data above is a tax of \$263.91 per \$100,000 of taxable assessed values based on current conditions. The proposed levy replaces an existing levy that will expire on June 30, 2025 and that currently costs \$219.85 per \$100,000 of taxable assessed value. If the proposed levy is approved, the tax per \$100,000 of taxable assessed value is expected to increase by \$44.06 per \$100,000 of taxable assessed value. The proposed levy will be assessed over one year.
